PDTC NON-RESIDENT TENNIS MEMBERSHIP
RULES & REGULATIONS

1. Annual membership period: One year (12 consecutive months) commencing on the "Anniversary Date" of membership.
2. Non-resident memberships will include: The use of the clubhouse, fitness center and racquet ball court (during normal clubhouse hours), the tennis courts, the clubhouse pool and participation in all PDTC social functions.
3. Tennis court regulations will be applicable to all PDTC members, resident and non-resident alike.
4. Each applicant for PDTC non-resident membership shall complete and submit to PDTC a membership application, together with a check for the first annual dues and a signed copy of the Club Rules and Regulations. No applicant shall be denied membership solely for reasons of race, creed, national origin or gender.
5. All PDTC rules relating to resident members shall also apply to PDTC non-resident members.
6. PDTC reserves the right to cancel its non-resident tennis membership at the end of any year.
7. PDTC may terminate the membership of any PDTC non-resident member upon giving to such member a written notice of termination if: in the judgment of the Board of Directors of PDTC.
 - a. PDTC determines as of the end of any given year, to terminate its non-resident membership program; and/or
 - b. Such member defaults in the payment of the from time to time annual membership dues; and/or
 - c. Such member violated the PDTC Rules and Regulations and/or these PDTC Non-Resident Membership Rules; and/or
 - d. Such member is guilty of conduct unbecoming a gentleman or lady on PDTC premises or is convicted of a felony.
8. Each PDTC non-resident member shall register and maintain a current address with the Club Manager. Any notice sent to the last address registered shall be deemed actual notice to such member.
9. Each non-resident member shall be responsible for damages from said member's acts or omissions or acts or omissions of said member's family and guests and shall be obligated to defend, indemnify and save harmless PDTC, its officers, directors and employees from and against any and all liabilities of any nature for damages sustained by or resulting from said member's act of omissions and that of such member's family and/or guests; PDTC nor its officers, directors and employees shall be responsible for any such acts or omissions.
10. Upon admission to membership, each PDTC non-resident member is granted solely a terminable license to use the above referenced facilities of PDTC; and no other rights (including, without limitation, any voting rights and access to any one or more of the five individual quads comprising PDTC) of any kind shall accrue solely by virtue of such member's membership. Each non-resident tennis membership shall be non-assignable and shall be limited exclusively to the individual to whom it is issued.

PDTC SOCIAL MEMBERSHIP
RULES & REGULATIONS

1. Social memberships will include: The use of the clubhouse, fitness center and racquet ball court (during normal clubhouse hours), the clubhouse pool and participation in all PDTC social functions.
2. You must have had a relationship with PDTC, either as a past homeowner or non-resident member for five (5) years.
3. Social memberships do not include tennis privileges. However, you may play tennis four (4) times per year and must pay all guest fees.
4. Each applicant for PDTC social membership shall petition the PDTC Board of Directors for approval. No applicant shall be denied membership solely for reasons of race, creed, national origin or gender.
5. All PDTC rules relating to resident members shall also apply to PDTC social members.
